Call to Order: The meeting was called to order by Beth Mercer at 12:28 p.m.

Review and Approval of March 2018 Financial Report: Jerry Olson

- General fund receipts for March totaled \$108,654. Net income for the month totaled \$30,421. The budget, receipts, and disbursements continue to be on track. Benevolence payments are now being made quarterly in accordance with the 2018 budget. No utilities payment was made in March. Laurel Riippa suggested that utilities be paid each month; Jerry Olson will talk with Sue Brickley and Sarah Lanier.
- Capital Campaign. Receipts in March totaled \$32,799; expenditures totaled \$25,996. A meeting is scheduled for April 16 to correlate the two data bases.
- Two editorial changes were suggested in the copy of the March report which will be posted to the web.
